### **Identification of the Responsible Party**

- The data required to be completed is specified on the form itself, and your refusal to supply it will imply not being able to process your request. Likewise, it assures us that all the information provided is true, truthful and relevant for the purpose for which we request it.
- It is important that, in order for us to keep your personal data updated, you should inform us whenever there is any change in it. Otherwise, we are not responsible for its veracity. We consider that, if you do not expressly cancel your personal data from our files, you remain interested in continuing to be incorporated into them until the Responsible Party deems it appropriate and as long as it is appropriate for the purpose for which it was obtained.

## **Data processing legitimation**

By accepting this privacy policy form, the interested party gives his express and unequivocal consent to the processing of his personal data, as long as SEQC considers it convenient for the management of the request that he makes.

#### Receiver of the data

Your data will be transferred in legally established cases and to the Sociedad Española de Químicos Cosméticos (SEQC).

#### International data transfer

We inform you that, for IT infrastructure and service reasons, your personal data may be transmitted to third-party countries outside the scope of the European Economic Area.





## **Data preservation**

The data provided will be kept:

- In the case that the data is provided to manage your participation in the IFSCC 33rd Congress, once the event is over, it will be blocked for the legally established time, before its destruction.
- The data provided to receive newsletters and informative communications will be kept until the interested party cancels their data or, failing that, until December 31st, 2023, the date on which all data provided will be destroyed, due to the end of the actions related to the congress.

## Rights of the interested parties

The owner of the personal data has the right to:

- Obtain confirmation as to whether the responsible party is handling the interested parties' personal data or not.
- Access your personal data, as well as request the rectification of inaccurate data or, where appropriate, request its deletion when, among other reasons, the data is no longer necessary for the purposes for which it was collected.
- In certain circumstances, the interested parties may request the limitation of their data processing, in which case only the Responsible Party will keep it for the exercise or defence of certain claims.
- In certain circumstances, and for reasons related to their particular situation, the interested parties may oppose to their data processing.
- In certain circumstances, by virtue of the portability right, the interested parties will have the right to obtain their personal data in a common-use and structured format, and on a mechanical reading system to transmit it to another person in charge.
